

## Melbourne City Football School

### Easter Camps 2026 – Early Bird Promotion

#### Terms and Conditions

##### **1. Promoter**

The promoter is Melbourne City Football School, operated by Melbourne City FC Pty Ltd (ABN 39 128 569 264) of 369 Casey Fields Boulevard Cranbourne East, Victoria 3977

##### **2. Promotion Period**

The “Early Bird” promotion ("Promotion") commences at 12:00am (AEDT) on 16 February 2026 and closes at 11:59pm (AEDT) on 1 March 2026 ("Promotion Period").

##### **3. Eligibility**

- 3.1 The Promotion is open to individuals who register and pay in full for any eligible Melbourne City Football School Easter Camp during the Promotion Period.
- 3.2 Participants must meet the standard eligibility requirements for Melbourne City Football School camps.
- 3.3 The Promotion is not available in conjunction with any other discount, promotion, or offer unless otherwise determined by the Promoter in its sole discretion.

##### **4. Offer Details**

- 4.1 Eligible participants who register for an eligible Easter Camp during the Promotion Period will receive:
  - (a) 20% off the full advertised retail price of the selected Easter Camp, with the discount applied prior to payment and the discounted amount payable at checkout; and
  - (b) One (1) Family Ticket to a remaining Melbourne City FC 2025/26 A-League Men regular season home game at AAMI Park.

- 4.2 For the purposes of this Promotion, a “Family Ticket” means four (4) general admission tickets comprising two (2) adult tickets and two (2) child tickets.
- 4.3 The 20% discount applies only to the full advertised retail price of the eligible Easter Camp and does not apply to merchandise, add-ons, optional extras, processing fees, or any other associated costs unless expressly stated.
- 4.4 The 20% discount will be automatically applied at checkout during the Promotion Period. To be eligible to receive the discount and the Family Ticket, registration must be completed and payment made in full during the Promotion Period.

## **5. Eligible Camps**

- 5.1 The Promotion applies only to Melbourne City Football School Easter Camps conducted during the 2026 Easter school holiday period.
- 5.2 The Promotion does not apply to other Melbourne City Football School programs, academies, clinics, or camps outside the specified Easter Camp program.

## **6. Redemption of Family Ticket**

- 6.1 The Family Ticket is valid for one (1) remaining Melbourne City FC A-League Men regular season home match at AAMI Park during the 2025/26 season, as determined by the Promoter in its absolute discretion.
- 6.2 Finals series matches are excluded. The Promoter may also exclude certain high-demand fixtures at its discretion. Without limitation, the Melbourne Derby (Melbourne City FC v Melbourne Victory) is expressly excluded from this Promotion.
- 6.3 The Family Ticket is subject to availability, stadium capacity, and any applicable ticketing and venue terms and conditions (including those of AAMI Park and the relevant ticketing provider).
- 6.4 Seating category and allocation will be determined by the Promoter. The Family Ticket is not transferable, not redeemable for cash, and cannot be resold. No replacement will be provided for lost, stolen, or unused tickets except as required by law.

- 6.5 Instructions for redemption will be provided by email following confirmation of eligible camp registration and full payment. The Family Ticket must be redeemed by the date specified by the Promoter and is not valid after the conclusion of the 2025/26 A-League Men regular season.

## **7. General Conditions of the Family Ticket**

- 7.1 The Family Ticket is not transferable, exchangeable, or redeemable for cash.
- 7.2 The Family Ticket cannot be upgraded, unless permitted by the Promoter at its discretion and subject to payment of any applicable price difference.
- 7.3 Standard Melbourne City FC ticketing terms and conditions and AAMI Park venue conditions of entry apply.

## **8. Payment and Registration**

- 8.1 To qualify for the Promotion, full payment for the selected Easter Camp must be completed within the Promotion Period.
- 8.2 Registrations that are incomplete, unpaid, or cancelled during the Promotion Period will not be eligible.

## **9. Cancellations and Refunds**

- 9.1 Standard Melbourne City Football School cancellation and refund policies apply.
- 9.2 If a participant cancels their camp registration and receives a refund, the Family Ticket will be deemed void and must not be used.
- 9.3 If a refund is processed after a Family Ticket has been redeemed, the Promoter reserves the right to deduct the value of the Family Ticket from any refund payable.

## **10. Changes and Force Majeure**

- 10.1 The Promoter reserves the right to amend, suspend, or withdraw the Promotion at any time, subject to applicable laws.
- 10.2 If a Melbourne City FC home game is rescheduled or cancelled, the Family Ticket will be valid for the rescheduled match or an alternative match as determined by the Promoter.
- 10.3 The Promoter is not responsible for any costs associated with attending a match, including transport, accommodation, or additional purchases.

## **11. Liability**

- 11.1 To the extent permitted by law, the Promoter shall not be liable for any loss, damage, or injury suffered or sustained in connection with this Promotion or the use of the Family Ticket.
- 11.2 Nothing in these Terms and Conditions excludes, restricts, or modifies any rights or remedies under the Australian Consumer Law.

## **12. Privacy**

- 12.1 Personal information collected in connection with this Promotion will be handled in accordance with the Promoter's Privacy Policy, available at <https://melbournecityfc.com.au/privacy-policy/>.
- 12.2 By registering for the Easter Camp, participants acknowledge and agree that the Promoter may collect, use and disclose their personal information for the purposes of:
- (a) administering the Promotion;
  - (b) conducting and managing the Easter Camp;
  - (c) communicating with participants regarding the Promotion and related activities; and
  - (d) related operational, safety and regulatory purposes.

- 12.3 The Promoter may disclose personal information to its related bodies corporate, event partners, service providers, contractors and professional advisers who assist in administering the Promotion or delivering the Easter Camp. Some of these recipients may be located overseas as described in the Privacy Policy.
- 12.4 If requested personal information is not provided, the Promoter may be unable to process an entry or facilitate participation in the Easter Camp.
